I supervised students who successfully secured the return of two deported veterans to the United States, both of whom were able to get their lawful permanent resident status reinstated. Worked with students to help a veteran obtain a pardon in North Carolina, in collaboration with the Wrongful Convictions Clinic, to restore eligibility for naturalization.

1. Appeals:

- Represented detained noncitizens on fear-based relief impact appeals before the Board of Immigration Appeals (BIA) and petitions for review before the U.S. Court of Appeals for the Fourth Circuit.
- Co-counseled and co-argued *Gordon v. Barr*, 965 F.3d 252 (4th Cir. 2020) before the U.S. Court of Appeals for the Fourth Circuit, which reiterated the categorical approach used to ascertain the immigration consequences of criminal convictions in the Fourth Circuit.

2. Habeas Corpus:

- Led case development for and co-counseled *Miranda v. Barr*, 463 F.Supp.3d 632 (D. Md. 2020), a class action in which a preliminary injunction was granted ordering the government to bear the burden to justify detention and the immigration judge to consider ability to pay and alternative conditions to detention in immigration bond proceedings held in the District of Maryland; Co-counseled the appeal before the U.S. Court of Appeals for the Fourth Circuit.
- Argued for and obtained a preliminary injunction in *J.M.G. v. Hayes*, No. 5:19-cv-00051 (W.D. Va. July 19, 2019) for the return of an unaccompanied minor to the jurisdiction of their case on the merits and step-down to the least restrictive setting in the child's best interest.

- Developed, implemented, and managed a BIA appeals referrals process and attorney training program for CAIR Coalition's Detained Adult Program.
- Trained and provided consultations to the Virginia Indigent Defense Commission's *Padilla* attorney and court-appointed defense attorneys on immigration consequences of criminal convictions.
- Developed and created the child habeas pipeline and toolkit on advocacy and litigation to secure the reunification or step-down of unaccompanied minors in prolonged Office of Refugee Resettlement custody (resources have been used for a national Vera Institute of Justice training).
