Winter Term is a two-week session during which students can complete 1 or 2 credits. For convenience, some classes are offered in a remote format and the small size of the sections allows for frequent instructor interaction.

Courses are open for enrollment to current LL.M. and J.D. students (excluding 1L students). Available seats may also be offered for enrollment to current UCONN graduate students, members of the bar and Connecticut residents aged 62 and over.

This course is to prepare students for the bar review and bar exam process with a focus on improving the analytical and writing skills needed to do well on practice bar exam questions, including essay, multiple choice, and /or performance questions. The course will cover selected specific topics tested on the bar exam with additional emphasis on refining memorization skills and learning how to self-assess writing and understanding of concepts. This course is not a substitute for a commercial bar preparation course but may be taken before or at same time as a commercial bar prep class.

Commercial Contract Drafting LAW7322-L15

This course will be held on campus – Starr Hall, Room 225 (weather permitting).

Also required: Review of Three Asynchronous Video presentations.

This course provides students with experience in the general principles of the drafting of commercial contracts. Through a study of the Model Note Purchase Agreement common to most debt transactions, students will learn to analyze an agreement, connect the language in the agreement to the terms of the deal, and draft protections commonly requested by clients. Knowledge of The Uniform Commercial Code A. 9 is helpful but not necessary.

Practice Ready Research (LAW7935-L15)

Asynchronous Offering

This course is designed to provide students with the research skills to be successful in their summer work and beyond. The course focuses on advanced research techniques in sources frequently used in the practice of law and will expose students to free, low-cost and for-free online legal and non-legal resources. This course is not open to students who have successfully completed or are currently enrolled in Advanced Legal Research.

Selected Academic Regulations:

- Students may enroll in up to two credits during the Winter Term.
- Open Courses may not be added after class has begun without the permission of the instructor. Permission may not be granted after the 2nd class meeting.
